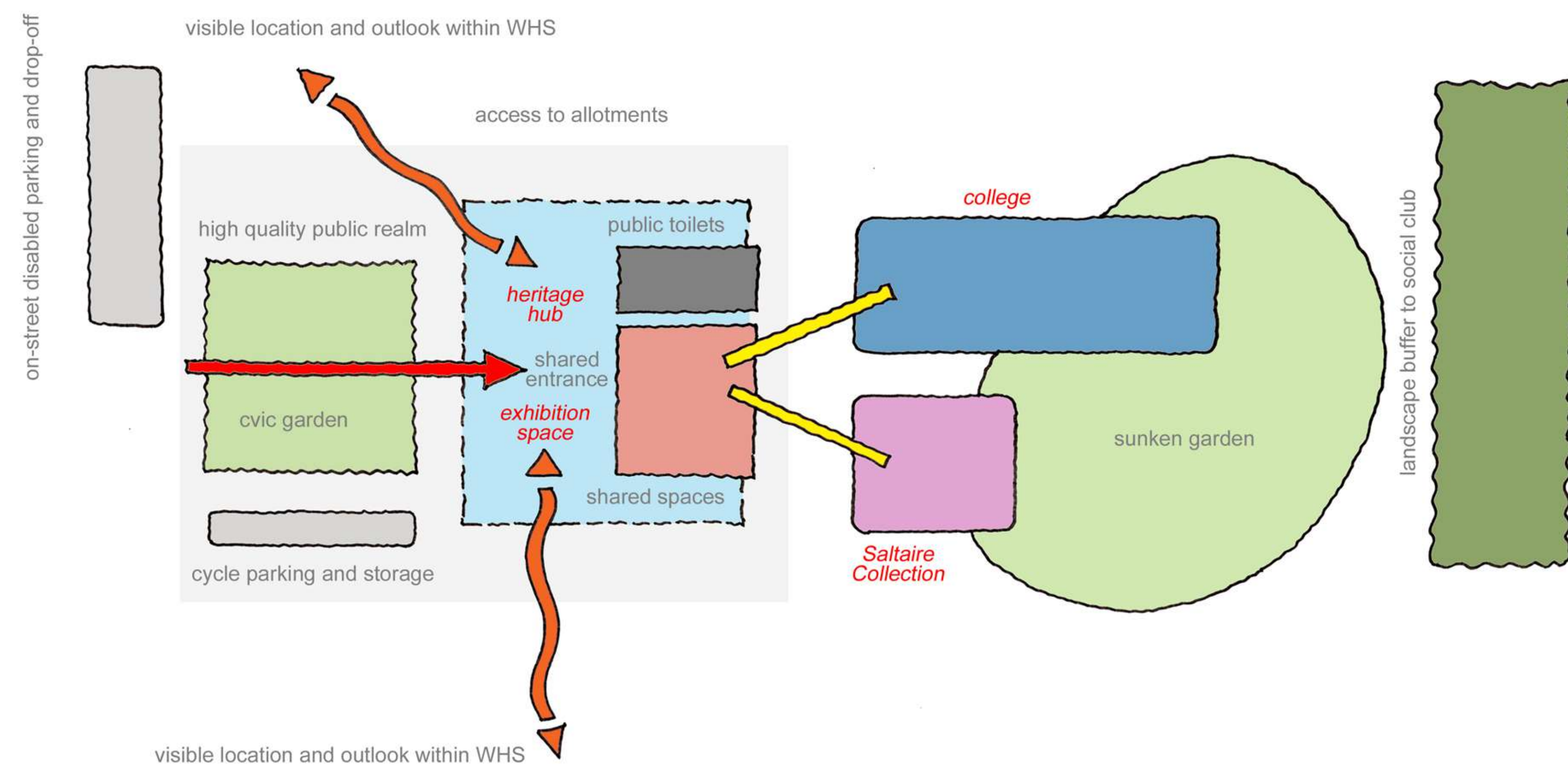
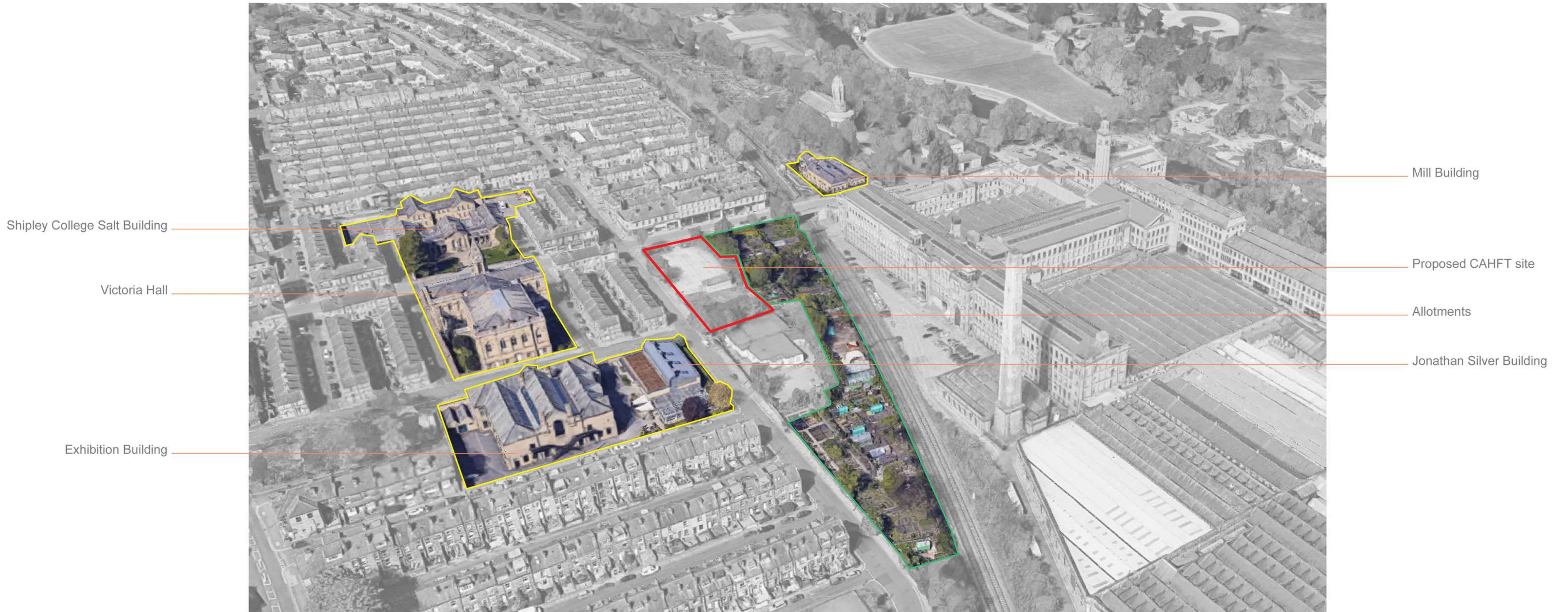


As well as Shipley College and the Saltaire Collection, additional stakeholders to the project are Shipley Town Council, who are responsible for the operation of Caroline Street public toilets and the adjacent allotments, and Bradford Metropolitan District Council who is the landowner. We have commissioned a parking survey to assess the impact of removing the public car park and for most of the day there is sufficient capacity at the nearby Exhibition Road car park, complemented at peak times with parking on street and in the privately owned Salts Mill car park. We therefore have an opportunity to reduce traffic and improve the visual amenity of this prominent site at the heart of the World Heritage Site through the creation of civic green space.



#### Shipley College

FE College offering full time 16-19 and part time 19+ education.

Circa 3000 learners and apprentices including learners with high needs.

A campus college split across 4 existing sites in Saltaire and a key stakeholder in the World Heritage Site.

Community-focused with many adult education short courses across an extended day into evening teaching sessions.

#### Spatial requirements:

Future Technologies Centre including: 5 teaching rooms; college registry, reception and administrative office space; circulation and WCs, display areas, internal and external breakout areas.

Teaching facility to include community and college learning spaces.

Flexible space strategy with exhibition / events space shared with Saltaire Collection.

Urban campus connected to other College buildings.

High quality external spaces to enhance learning environment and World Heritage Site setting.

#### Saltaire Collection

Education programme of Saltaire World Heritage Education Association (a charity formed in partnership with The Salt Foundation, Shipley College and Saltaire United Reformed Church).

Located in the Exhibition Building and part of Shipley College Learning Resource Centre.

Manages the Saltaire Collection and delivers learning resources about Saltaire to learners of all ages.

Collection holds 6,000 items including documents, photographs, plans, newspaper cuttings, books, objects.

#### Spatial requirements:

Heritage hub comprising: Visitor information point; community teaching space; archive facility including secure storage area and search room / reading room; exhibition and interpretation space.

Spatial overlap with Shipley College.

Flexible space strategy with exhibition / gallery area and community classroom for talks, curated events, activity sessions.

Shared teaching facility but able to separate educational programme activities and college learning spaces.

Accessible and visible location in the World Heritage Site.

#### Shipley Town Council

Existing toilets managed by Shipley Town Council include accessible WC, baby changing facilities, cleaner's room. Also responsible for the management of Caroline Street Allotments adjacent the site.

#### Spatial requirements:

New public toilets including: WCs including 1 accessible WC, cleaner's store, baby changing facilities, showers; Access to existing allotment gates; accessible drop off space, secure cycle parking, external orientation and arrival spaces for visitors.

Active travel focus on cycling and walking within an enhanced public realm.

High quality garden spaces and tourism facilities, fully accessible in a visible location with secure, well-lit public areas.

An enhanced visitor experience to Saltaire.

Pedestrian access to allotments maintained, stepped ramped access for barrows and nearby short stay street parking.
