INTRODUCTION

The following information is provided to assist staff joining the College to understand and appreciate the work content of their post and the role they are to play in the organisation. However, the following points should be noted:

OVERALL PURPOSE OF THE JOB

In this hybrid role, you will act as a pivotal link between the Quality Standards team and Departmental Operations. Reporting to the Head of Quality & Standards and supporting the Head of Department, you will promote excellence and continuously improve the learner experience.

Your mission is dual-faceted: you will monitor curriculum performance through data-driven reporting, while simultaneously providing the high-level administrative support necessary to ensure the department operates efficiently. By blending quality assurance with operational coordination, you will ensure regulatory compliance, maintain accurate records, and drive targeted improvement strategies across the organisation.

DUTIES AND RESPONSIBILITIES

1. Integrated Quality Monitoring & Inspection Readiness

Support with the coordination of the departmental quality cycle, including work scrutiny, thematic reviews, and auditing. By maintaining standardised "Curriculum Management Folders" and audit-ready documentation, you ensure the department remains compliant with Awarding Organisations, Ofsted frameworks and internal monitoring requirements at all times.



2. Strategic Data Management & Student Records

Proactively manage the college MIS to track and monitor student attendance to support retention, and achievement. You will transform data into actionable reports for Course Leaders and the HoD, identifying "at-risk" areas and systemic trends to support timely interventions. Provide targeted support to key service areas, including admissions, enrolment, and the placement team, as required, ensuring the maintenance of high-quality student records and total data compliance at every stage.

3. Departmental Operations & Teaching Support

Provide comprehensive administrative oversight, including managing correspondence, procurement, and departmental databases, to reduce the "administrative burden" from teaching staff. You will help assist the department by coordinating all logistics for meetings, workshops, and guest speakers, providing the essential administrative support needed to ensure the curriculum team can focus exclusively on high-quality delivery and the learner experience

4. Compliance, Safeguarding & Regulatory Oversight

Support the department lead with regulatory adherence, ensuring all activities meet GDPR, Health & Safety, and funding audit standards. You will act as a guardian of safeguarding processes, ensuring staff are trained in reporting procedures and maintaining the strict confidentiality of sensitive student and staff data.

5. Staff Induction & Quality Coaching

Lead the "Quality & Compliance" induction for new hires to ensure "Day 1 readiness." You will guide staff through mandatory course planning templates and provide initial training on MIS and departmental administrative tasks, ensuring total uniformity in quality documentation across the team from the outset.

6. IQA, Teaching & Learning, and Stakeholder Collaboration

Act as the central communication hub between the Programme Manager/Deputy Director of Quality, the Head of Department, and external stakeholders. You will communicate awarding body standards and lead the coordination of Teaching & Learning (T&L) activities, including observations, learning walks, and the collation of OTLA outcomes. By monitoring the student lifecycle, you will ensure assessment and verification meet "Gold Standard" benchmarks while identifying skills gaps to inform targeted CPD. Through showcasing innovative practices, you will drive a culture of academic integrity and continuous improvement.

This role requires adherence to all college policies, with a strong focus on confidentiality, data protection, and safeguarding.
