- Work with partners and community organisations to extend access to learning, promote social inclusion, and engage underrepresented groups in education and training.
- Monitor and analyse performance data, identifying trends, gaps, and areas for improvement, and implementing strategies that drive measurable progress and qualification achievement.
- Provide leadership, mentoring, and professional development for staff delivering English, maths, and ESOL to ensure consistently high standards of practice and innovation.
- Evidence of the impact of English, maths, and ESOL initiatives through improved learner progress, retention, attendance, and achievement rates.
- Oversee the planning, delivery, and quality assurance of the College's leisure learning provision, including courses such as French, Spanish, and Creative Writing, ensuring these programmes provide enriching and accessible learning opportunities for adult learners.
